About Ingrained Foundation:



About our Northern Rivers Large Grants Program:

Our local grants program is an important initiative of the foundation that aims to create sustained positive change by directing funds to support our community where and when it's needed.

In 2024 and beyond, we will be focussing on projects based in the Northern Rivers region, under the following impact areas:

• Community Capacity Building

Develop and strengthen the skills, instincts, abilities, processes and resources of individuals and organisations.

• Ecological Resilience and climate action

Enable environmental regeneration, preservation, and resilience. Support education and advocate.

Social Cohesion

Promote and support cooperation and inclusion, develop opportunities and capabilities for social wellbeing.

• Systems Change and Social Innovation

Engage in consultation and collaboration while catalysing innovative solutions, along with working with alternative economic/ impact models.

Applicants will be asked to detail which category their project addresses.

To reflect the diverse range of work in our community, **grants are available between \$10,000 to \$30,000.** We will ask applicants to not only outline how the funding will be spent, but also how the impact will be enduring or sustained beyond this investment.

About the Guidelines:

This guideline document has been created to assist with the grant application process. It sets out eligibility, submission steps and requirements, key dates, the assessment process, and contact details for further information.

Please ensure that you have read and understood these guidelines before applying.

Eligibility:

For 2024, applicants must:

- Be a not-for-profit with DGR status, or be in partnership with a DGR status organisation with an auspicing agreement with the applicant.
- Implement the project in the Northern Rivers region please refer to map below.
- Address one of four impact areas listed above
- Develop a distinct project with milestones and outcomes. Project completion must be before **30th of June 2025.**
- Complete and submit the application and accompanying documentation by 5pm, 17th April 2024.

Submission Steps:

- **1.** Read and understand these application guidelines.
- 2. Prepare all relevant and required documentation (see below Submission Requirements).
- **3.** Read through the online application form.
- **4.** Compile all supporting documents in pdf format.
- 5. Complete and submit the online form and documents.
- 6. The applicant will receive a confirmation of submission email.

Key Dates: Grant applications opening - Wednesday 20th March Information Session – Tuesday 26 March Grant applications closing - Wednesday 17th April Grant applications reviewed and presented to Board - Wednesday 15th of May Informing successful/unsuccessful applicants by - Wednesday 29th of May Announcement - Tuesday 25th of June Congratulatory Event in late June

Submission Requirements:

Applicants will be asked to submit information about their organisation, as well as detail what project they are planning to run, and requested funding amount. Applicants are recommended to **include as much supporting information that is relevant to their application as possible.**

There are three parts to the application form:

Assessment Process:

Applications will be assessed by Ingrained Foundation's Grants Committee, who will score the application on four key themes:

Impact

- Is there a clear link between the aims of the project and the beneficiaries in need?
- Does the project address an area of need within the Northern Rivers?
- Does the project address one or more key impact areas?

Timeline

• Does the project have clearly defined milestones and an achievable timeline?

Feasibility & Financials

• Does the organisation have the capability and resources to complete the project?

Sustainability

• Will the project's benefits continue on after grant funding has been spent?

If the Grants Committee feels that more information is required, the contact person for the application may be contacted after the closing date to provide further information.

The Grants Committee will meet in May to make a recommendation on funding recipients, with the successful applicants notified by 7th May 2024.
